(1) I hereby acknowledge and assume all the risks of participating in IUTA sanctioned events. I acknowledge running, bicycling, swimming and/or other portions of IUTA sanctioned events are inherently dangerous and are an extreme test of my physical and mental limits that carries with them the potential for serious bodily injury, permanent disability and death, as well as property damage. I acknowledge and agree that it is my responsibility to determine whether I am sufficiently fit and healthy enough to safely participate in IUTA sanctioned events. I attest and certify that I am or will be sufficiently fit and physically trained to participate in IUTA sanctioned events. I certify that I have not been advised against participation in IUTA sanctioned events by any healthcare provider. I have no physical or medical condition that would endanger myself or others if I participate in IUTA sanctioned events, or would interfere with my ability to safely participate in those events.

(2) I accept responsibility for the condition and adequacy of my competition equipment and my conduct in IUTA sanctioned events.

(3) I declare that I have informed myself thoroughly about the swim, bike and run course as well as the conditions of the transition zones. I also declare that I know and will respect the relevant road traffic regulations. I declare that I have informed myself sufficiently about the climatic conditions of the competition region. I am aware that climatic conditions can deviate greatly from the various forecasts of the relevant experts and have fully prepared myself for this.

(4) I am sufficiently insured. I am holding a third-party insurance that covers all damages that I may impose on any other persons or/and objects during my participation of a competition. I declare that I have health insurance that is also valid in the country of the respective racing location.

(5) I permanently waive, release and discharge the IUTA/the IUTA committee members from any and all claims, liabilities of every kind, demands, damages (including direct, indirect, incidental, special and/or consequential), losses (economic and noneconomic), and causes of action, of any kind or any nature, which I have or may have in the future, including court costs, attorneys' fees and litigation expenses (individually and collectively), the "claims" that may arise out of, result from, or relate to my participation in IUTA sanctioned events or my travelling to or from this events, including light negligence, property damage and damages of any kind, property theft, and claims relating to the provision of first aid, medical care, medical treatment, or medical decisions (at the events site or elsewhere), and any claims for medical or hospital expenses, even if such claims are caused by light negligent acts, omissions, or the carelessness of the released persons. The aforementioned exclusion of liability does not apply to damages caused by willful misconduct and gross negligence of one or more IUTA committee members.

(6) I further covenant and agree not to sue any of the released parties for any of the claims that I have waived, released, or discharged herein. I confirm to indemnify, defend, and hold harmless the released parties from any and all expenses incurred, claims made by me or other individuals or

entities, for liabilities assessed against the released parties, including but not limited to court costs, attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, my breach or failure to abide by any part of this agreement, my breach or failure to abide by any of the race sanctioning IUTA's competitive rules and/or my actions or inactions which cause injury or damage to any other person.

(7) I give my unrestricted permission for the event organizer to transmit my registration data such as full name, date of birth, gender, nationality and contact details to the IUTA.

(8) I hereby grant IUTA the right, permission and authority to store and process my personal data electronically and that the IUTA may use my personal data in publications such as their website or on social media platforms without any restriction.

(9) I hereby grant IUTA the right, permission and authority to use my name, image, voice, and/or likeness, without compensation, captured during IUTA sanctioned events or related events, its affiliated entities or contractors, and/or the media in any photographs, videotapes, CDs, DVDs, broadcast, telecast, podcast, webcast, recordings, motion pictures, commercial advertisement, promotion materials, and/or any other record of this event for any purpose whatsoever.

(10) I have read and understand the IUTA rules in its entirety and will fully respect them. I am aware that by not respecting the IUTA rules in its entirety the event organizer or any representative of the IUTA can pull me out of the race at any time.

(11) I agree that in case of any IUTA suspension, my name, the violation and the duration will be published on the association website.

(12) I declare that I am not competing under the influence of any illegal or banned substances, determined by WADA and that I accept the IUTA anti-doping regulations in its entirety and the WADA anti-doping regulations in its entirety.

Important for NADO / WADA:

I give my unrestricted permission that any results or the complete communication referring my anti-doping tests will be transferred to IUTA (anti-doping@iutasport.com) by the respective anti-doping agency or the appointed institute.

(13) I declare that there are no illegal technologies on my bike, such as drive engines etc.

(14) I fully respect the IUTA constitution.

(15) I agree that the IUTA contact me by post and/or e-mail and/or phone.

(16) I am aware that without IUTA membership I am not entitled to prize money or trophies and that I have no active and passive voting rights.
